Dear Friends of FACT and the Glendive Dinosaur & Fossil Museum,

A 2016 article in Science World Report declared, “Tweak in Gene Expression May Have Allowed Our Ancient Ancestors to Walk Upright.”<sup>1</sup> With the constant barrage of evolutionary declarations like this in the media, it would be easy to assume that the case for evolutionary origins is a “done deal.”

To make the case for evolution, secular science writers often dip into a long list of logical fallacies to prove their case, as illustrated by Dr. Jason Lisle in his book, The Ultimate Proof of Creation. One of the most common in evolutionary arguments, the fallacy of equivocation, is found in the above-mentioned article. As Lisle informs us, equivocation happens when the meaning of a word is changed during an argument.<sup>2</sup>

How does this happen in the evolution/creation debate? In the article cited above, the author uses the word “evolution” to describe the variations in armor of the threespine stickleback fish. Depending on the environment, the stickleback can have a thick armor of bony plates or smaller, lightweight plates. In this instance, evolution is defined as adaptation *within* a specific species of animal.

But then the definition changes. The God-given abilities the stickleback possesses to be able to adapt to different environments are somehow used to prove the evolutionary steps that supposedly changed apes into humans! In the remainder of the article, evolution is defined as the idea that all life descended from a common ancestor, a huge leap from animals adapting to their environment.

Understanding mistakes in logic can help expose the inconsistencies in evolutionary thinking. At the Glendive Dinosaur & Fossil Museum, we seek to point out to our visitors that the Biblical worldview is consistent with the scientific evidence we find in the fossil record. We want our guests to see that the world around them is best explained by the events described in Scripture, from special creation to Noah’s global Flood. Once you know the facts, it’s the only logical conclusion!
